In compliance of Rule 30 (f) of Madhya Pradesh Outdoor Advertisement Media Rules 2017, I therefore undertake to submit the Structural Certificate of the OMD and also submit the certified annual audit of the OMD from second year onwards, I understand that if I fail to submit the certified annual audit of the OMD from second year onwards of the said OMD within Thirty (30) days, as per the provisions of Rule 22, the penalty of Rs.5/- / Per

Sq. Ft. / Per Day shall be imposed on me and I have to pay the penalty, in case of continuing violation beyond Sixty (60) days, failure to which, the OMD approval shall be withdrawn by Municipal Corporation Bhopal.

I undertake that, in compliance of Rule 32 of Madhya Pradesh Outdoor Advertisement Media Rules 2017, we shall not display or exhibit any advertisement on the OMD that shall be deemed to be negative advertisement for the purpose of Madhya Pradesh Outdoor Advertisement Media Rules 2017.
